## Concerned about asylum seekers and migrants being detained in substandard conditions? Want to see families reunited?

Members of our parish have been moved to research this issue and identify ways you can voice your concerns and lend tangible support to those working on behalf of asylum seekers and migrants. St. Luke's Advocacy Council believes we have a scriptural basis for sharing this information with the parish.

"Do not mistreat foreigners who are living in your land. Treat them as you would an Israelite, and love them as you love yourselves. Remember that you were once foreigners in the land of Egypt. I am the LORD your God.

We realize the broader immigration issue is a large and complex one. We also believe that many will agree with the Scripture's directives to love others as ourselves and to care for the children. Clearly, we can do better as a nation in how we provide accommodations and services to those in our care as they await the outcome of the judicial process.

- 1. Call your local, State, and Federal representatives and voice your feelings on the practices against immigrants at the border and throughout our country!

Atlanta is one of the cities targeted for ICE raids. Stewart Detention Center in Lumpkin, GA imprisons nearly 2,000 people. Irwin County Detention Center in Ocilla, GA imprisons more than 1,200 people. Robert A. Deyton Detention Facility in Lovejoy, GA imprisons nearly 800 people. Six Georgia counties have signed 287(g) agreements allowing local law enforcement to serve as an enforcement arm of ICE. Read more here:
