 - A motion was made to approve the July Minutes and the Financial Reports as presented. Motion and Second: Mariah/Laurel - unanimously approved.

- Project (Fire alarm / roof) Budget <u>Overview</u>
- *Grace House Rental Agency / Section 8?
 - Motion: Use Select Homes to manage the property using their full service option.
 They have 410 homes under management. Moved/Seconded: Barbara/Pat Unanimously approved.
 - Would we approve a Section 8 rental? Yes.

- *Roof <u>Proposal</u> (check out these engineering reports (<u>1</u> and <u>2</u>) and the <u>quote</u>) Check out these and other documents here.
 - Administration Committee recommends contracting with Pisgah Roofing Restoration for the Endura metal roof option (heavier gauge) - \$106,976.43 -Vestry approved by unanimous vote
- *Fire Alarm Proposal and Updated Proposal -
 - Motion: Approve the Asheville Security System wired system vs wireless. Cost estimate is \$35,300. \$45/month for the service. Motion/Second: Admin committee recommendation - unanimously approved

Budget.

- Ultimately two banks were considered for a loan to pay for the roof and fire alarm. (add info re: terms from link)
 - A motion was made and seconded (Barbara/Kathie) to use United Community Bank for the loan with the following terms:

■ Loan amount: \$150,000 max ■ Type of Loan: Permanent Loan

■ Interest Rate: 5.20%

■ Loan Origination Fee: ½% of loan commitment

Payment: Line of credit-interest only for 6 months
 20 yr amortization with a 5 yr balloon note.

No prepayment penalty unless refinanced with another institution.

■ Closing Costs: \$400 plus Attorney's Fees

■ The goal is to pay it off prior to the balloon payment due date

The motion passed by unanimous vote.
